EXECUTIVE SUMMARY:

The report for this period continues to highlight that Council has performed very well and reflects a commitment from the executive and the staff to deliver on the range of matters outlined in Council's Corporate Plan and the 2016/17 Budget.

REPORT

1 CURRENT SIGNIFICANT ISSUES

EBA Update

The Queensland Industrial Relations Commission (QIRC) has released an amended version of the Queensland Local Government Modern Award 2014. The QIRC has relied on its own powers to vary an award to satisfy the Minister's direction to restore certain conditions of employment by 31 August 2016. The Minister agreed to extend this date to 1 September so as to include pay rates in line with the state wage case decision. The interim award is scheduled to be replaced by an amended award in coming weeks to comply with the requirements of the Industrial Relations Act and Ministers request.

The LGAQ and other parties will have a week to review and provide written responses to the draft before attending one or more QIRC conferences to address concerns raised in the responses. We expect the matter will subsequently be referred to a full bench of the Commission for hearing and final determination.

The single modern award was about 100 pages long while the interim award - even with some conditions being expressed as references to clauses in certain pre-modernised awards - is around 250 pages. The final award is expected to be more than 400 pages to accommodate the Minister's direction to restore the award contents to that which existed before Award Modernisation began in 2014.

The amended award is yet to be released so any bargaining would be premature at this time.

IR LEGISLATION

At the same time as the release of the interim varied Local Government Modern Award, the Honourable Grace Grace, Minister for Industrial Relations, introduced in to the house a bill to create a new Industrial Relations Act.

The new Act will replace the current Industrial Relations Act and effectively cover state government and local government sectors.

The new Act purportedly captures all the reforms recommended by the Taskforce set up by the state government to review the current industrial relations system operating in Queensland.

A full synopsis of the bill and its implications for councils will be released shortly and will also be a topic of discussions at LGAQ workshops currently being planned.

SafetyCircle

Council is committed to improving our health and safety culture and performance. The introduction of the SafetyCircle program to the organisation is a critical step in doing so. Through staff engagement at all levels, strong leadership and regular reinforcement we create a workplace where everyone goes 'Home Safe and Well Today'.

The objectives of the SafetyCircle Program can be summarised as:

- Simplification of WHS for effective risk management and injury prevention.
- Ownership personal engagement and actions by all Leaders and Workers.
- Leadership at all levels to build and sustain the desired positive cultural state.

The goal is to implement the SafetyCircle Program throughout Council and is being delivered in a staged process based on geographical locations.

To date over 160 management and employees have undertaken the initial training including all General Manager and Branch Managers.

2. MAJOR KEY PERFORMANCE INDICATORS

FINANCE

Council's operating position at month end is a \$3.5M surplus, \$2.6M favourable to Council's 2016/17 Budget.

This favourable variance is driven by less than anticipated materials and services (\$1.8M) and finance costs (\$.8M). This is offset by less than anticipated miscellaneous revenue (\$.4M) and revenue from fees and charges (\$.3M).

EMPLOYEES

Council's employee number as at 19 October 2016 was 1200, of which 995 are full-time permanent.

Turnover rate is currently tracking at 9.71%, which is below the KPI of 10% (this figure is based on full time permanent / part time permanent staff and does not include casual, temporary or agency staff).

Councils Lost Time Injury Rate (LTIFR) of 19.82 is lower than the three year average of 26.16.

The Lost Time Injury Duration Rate (LTIDR) of 35.15 is higher the three year average of 23.78.

Councils Days Lost due to injury for the financial year to 30 September 386 days is higher than the three year average of 290 days.

CAPITAL

The 2016/17 Capital Works Summary report is tabled on a monthly basis. Each department and the relevant committee would have discussed and reviewed this at the relevant workshop.

As at the end of September 2016, Council has spent approximately 20.1% of the capital budget with expenditure totalling \$35.9M.
