



## **Face of Cairns News competition**

### **PROMOTION TERMS AND CONDITIONS**

#### **Introduction**

1. The Promotion is the Face of Cairns News - newsreader competition.
2. The Promoter is Cairns Regional Council (ABN 24 310 025 910).
3. Information regarding how to participate in this Promotion and information regarding redemption of any prizes forms part of these Terms and Conditions. To the extent that any of the information is inconsistent with these Terms and Conditions, these Terms and Conditions prevail.
4. Entry into this Promotion is deemed acceptance of these Terms and Conditions. By submitting an entry into this Promotion, entrants warrant that they have read, understand and agree to be bound by these Terms and Conditions.
5. Any personal information requested is necessary for Cairns Regional Council to enter you in the competition. By entering the competition, you consent to Council collecting your personal information for the purposes of this competition.

#### **How to enter**

1. The competition is open to all ages who reside in the Cairns Regional Council local government area, with the exception of immediate family of the Marketing and Communications branch of Cairns Regional Council.
2. You may enter the competition more than once.
3. Entries will be filmed by Cairns Regional Council during the Cairns Show, 17-19 July 2019.
4. Entrants are to present a pre-prepared Council news piece at the Council stand located at the Cairns Show 17-19 July 2019 which will be professionally filmed and edited by Cairns Regional Council.
5. Entries will be edited and aired via Council's Facebook page.
6. All entries must have a valid talent release entry form. Entrants aged under 18 must have parental/guardian permission.

## **General terms and conditions**

1. If the entrant is under the age of 18 years, the entrant's parent or guardian:
  - a. consents to the entrant participating in the Promotion; and
  - b. is responsible for ensuring that the entrant is familiar with these Terms and Conditions at the time of participation and complies with them.
2. A copy of these Terms and Conditions can be obtained from the Promoter.
3. No responsibility is accepted for late, lost or misdirected entries.
4. The winner's design will be used on Council's social media channels to promote events and messages where appropriate.
5. A shortlist of 10 entries will be judged by a panel of staff from Cairns Regional Council's Marketing and Communications unit. The judging panel's decision will be final and no correspondence regarding their decision will be entered into.
6. The overall winner of the competition will be judged via an online voting system promoted through Council's Facebook. First, second and third places will be determined via the number of votes received during the voting period. The voting period will be between 8am Monday August 5 through to 5pm Friday August 30.
7. Each shortlisted news clip will be available to watch on Council's Facebook page and Youtube channel.
8. The prize pool comprises ten (10) individual prizes. The major prize is one GoPro HERO 7 (Valued at \$599); one (1) Cairns Taipans 2019/20 Family Pass (four fast break tickets for each home Cairns Taipans Game – valued at \$854); double pass to the Cairns Performing Arts Theatre. Two runners-up will receive a family pass to a 2019/20 home Cairns Taipans Game (four fast break tickets to a Cairns Taipans Game of their choice), plus a \$50 eftpos giftcard and a double pass to either the Tanks (first runner-up) or Munro Martin Parklands (second runner-up). There will be seven (7) minor prizes of a family pass to a Cairns Taipans home Game. Dates for the Cairns Taipans home games are yet to be determined and winners will be advised of dates once released by the National Basketball League.
9. Prizes, or any unused portion of a prize, are not transferable, redeemable or exchangeable for cash unless otherwise specified. Each prize must be taken as stated and no compensation will be payable if a winner is unable to use the prize as stated.

12. If the winner does not claim the prize or cannot be contacted by email, messaging service or phone within 7 days of the prize draw, Cairns Regional Council may choose to redraw the prize until a contactable winner has been located and the prize is claimed.

Council reserves the right to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right to disqualify any entrant who tamper with the entry process or who submits an entry that is not in accordance with these Terms and Conditions.
