- I hereby apply for registration of the animal described and declare that the details are correct to the best of my knowledge.
- I recognise that failure to comply with the Cairns Regional Council Local Laws or the *Animal Management (Cats and Dogs) Act 2008* may result in the Council taking action against myself.
- I have provided a sufficient enclosure to contain my animal in accordance with the Cairns Regional Council Local Laws. Keeping of dog/s on a lead or runners is not considered a sufficient enclosure. I understand that failure to keep my animals within the enclosure could result in action being taken against myself.
- I acknowledge my dog/s must be walked on a chain, cord or leash by a person who is physically able to control the animal.
- I acknowledge I am only allowed to have 1 dog and/or 2 cats if my property is less than 450m<sup>2</sup> or 2 dogs and/or 2 cats if my property is more than 450m<sup>2</sup>.
- I understand that my dogs must wear the registration tag at all times. Should the tag become lost and/or damaged, I must contact Cairns Regional Council for a replacement tag.
- I understand that it is a requirement under the *Animal Management (Cats and Dogs) Act 2008*, that my animal has a permanent identification device (microchip) implanted in it.

**Please note:**

- All dogs and cats over the age of three (3) months must be registered and microchipped.
- Payment of relevant fees must be received by Council before new applications for registration can be processed. Online dog registration is available at [www.cairns.qld.gov.au](http://www.cairns.qld.gov.au) Payment can be made by cheque or money order mailed to Cairns Regional Council, PO Box 359, Cairns or by visiting one of our customer service centres.
- Under the *Animal Management (Cats and Dogs) Act 2008*, if you own an American Pit Bull Terrier or Pit Bull Terrier, Dogo Argentino, Fila Brasileiro (known as Brazilian Mastiff), Japanese Tosa or Perro de Presa Canario (or Presa Canario) you must apply to Council for a permit to keep a Restricted Dog.
