#### Cairns Traffic Advisory Committee (CTAC) Minutes – 12 September 2023

This report provides the notes, agreements, and actions from the Cairns Traffic Advisory Committee (CTAC) meeting of 12 September 2023. See Attachment 1.

The main topics discussed were:

- Safety concerns on various streets and traffic signals
- Safety concerns raised by Councillor's on different roads
- CRC matters / projects various matters
- TMR matters / projects various matters
- Speed limit reviews

#### **BACKGROUND:**

CTAC provides a forum for discussion and information exchange between the relevant groups and the Council about issues of concern relating to road safety and traffic matters. The scope of the committee includes any strategic traffic-related issue that affects all or most committee members and is within the boundaries of Cairns Regional Council's area of responsibility.

#### COMMENT:

Invitations for the meeting of 6 March 2023 went out to representatives from Council, Transport & Main Roads (incl TransLink), Queensland Police Service, Kinetic, Cairns Taxis, RACQ, Education Queensland and Queensland Rail. The meeting had representation from CRC Councillors and officers, TMR, TransLink, Kinetic and Cairns Taxis

#### **CEO Month in Review – October 2023**

The CEO's monthly review summarises a number of Council's operational activities and associated metrics from the previous month, as well as providing relevant updates on major initiatives and projects. See Attachment 2.

#### <u>Australian Audiology Conference Awards Dinner – Extension of Event Hours</u>

Council has received an event application that includes a request to extend activities beyond the 10pm threshold as specified in the Cairns Esplanade Usage General Policy. Any decision to extend activities beyond this time requires full Council approval.

Given the nature of the event and the proposed set up, officers do not anticipate that activities will have an adverse or contentious effect on surrounding residents or the public.

#### **BACKGROUND**:

The Australian Audiology Association Awards Dinner, presented by Ochre Restaurant and Catering on Friday 10 May 2024, forms part of a 1-day conference being held in Cairns on 10 May 2024.

The event will host a dinner for approx. 600 guests made up of field professionals from around Australia, an Awards Ceremony and live music with guests departing at midnight. Bump in will occur on Thursday and Friday 9 and 10 May, bump out will take place on Saturday 11 May.

Carins Regional Council's Esplanade Usage Policy does not routinely support event activities and associated noise on the Esplanade for open air events past 10pm. Consideration to extensions beyond this time must be endorsed through a full Council Resolution.

#### **Developing Northern Australia Conference 2025**

The Developing Northern Australia Conference is an annual conference which aims to bring together key representatives from government, business, industry and economic development agencies to drive sustainable development and policy for Northern Australia. The conference takes place over three days, is generally held in August each year and was last held in Cairns in 2017. The 2023 conference was held in Darwin, NT and the 2024 conference will be held in Karratha, WA. The conference is organised by the Association for Sustainability in Business Inc (ASBI) with the conference agenda, content etc overseen by an organising committee chaired by Professor Allan Dale.

ASBI are seeking proposals from potential host cities for the 2025 conference which is expected to be held in Queensland. ASBI has issued a request for proposal document with submissions from potential host cities due on 24 November 2024. Conference support (both cash and in kind) from the potential host city is a key consideration in deciding the host location. Bringing the conference to Cairns would provide a range of benefits including economic benefits from conference attendance/visitation (the conference is expected to attract over 400 delegates) and the ability to highlight priorities/issues of particular importance to our region with key decision makers 'on the ground' through site visits, conference content and networking. TTNQ are coordinating a submission and TTNQ representatives and council officers have been working collaboratively with representatives from Advance Cairns, RDA Tropical North Inc, FNQROC and potential conference venues regarding the proposal and their potential support. To support the submission for Cairns to host the conference in 2025, it is recommended that Council provide in-kind support through the provision of a Council venue (expected to be the Tanks) on a dry hire basis to host the initial networking function or conference dinner (cost estimated to be in the vicinity of \$5,000 to \$7,500 (ex GST)) and a cash contribution of \$20,000 (ex GST) towards conference costs. If the bid is successful, these costs would need to be provided for within Council's operating budget for the 2024/25 and/or 2025/26 financial

years. Based on current budget levels, there is expected to be capacity in Council's future advocacy operating budget to accommodate these costs.




- The event was expected to host up to 162 pro athletes and 340 spectators (actual attendance data not yet received).
- 2023 was the 12<sup>th</sup> time the event had been held in Cairns.




# **Lost Time Injury Frequency Rate**

Dog attacks slightly reduced this month, barking complaints on par with last month. Wandering complaints slightly increased this month.


#### Animals Impounded:

## **Major Projects & Initiatives**



### **Resource Recovery 2040 Roadmap**

- Stage 2 underway; with Program Prioritisation completed
- Detailed options analysis commenced, including long-listing to short-listing process

### **Cairns Water Security Stage 1**

- Council resolved to Award an Early Contractor Involvement (ECI) Agreement to two parties in early 2023.
- ECI Phase has reached completion, with Proponent D&C Offers submitted. Evaluation has since commenced and is currently in progress.
- Formal Cultural Heritage Management Plan (CHMP) negotiations underway





### **Smart Water Meter Project**

- Total of 7,600+ SWM meters installed with stable communication of water usage.
- Supply of meters is sufficient with no current or forecasted stock issues.
- Utility Services installation team averaging 600 new meters installed per month.
- Mid-2024 increase of installation teams is on track to further increase installation rates.

## **Major Projects and Initiatives**



#### **Health Compliance**

Renewal notices for Food Business licenses were issued in August, and the payment deadline of 30 September was met with great responsiveness. Out of the 1142 food businesses that received renewal notices, an impressive 1130 have already completed their payments in full. This represents a 99% compliance rate, with only 12 businesses currently engaged in positive discussions with Council officers to promptly settle their outstanding accounts. The overall commitment to license renewal is commendable, and we are actively working with the remaining businesses to ensure the smooth finalisation of their accounts.

#### **Local Law Adoption**

On 9 August 2023 Council resolved to undertake public consultation in relation to the Local Laws and the anti-competitive provisions identified and to consult with relevant State government departments regarding the State Interest in the Local Laws. Council undertook public consultation and State Interest Checks during the period from 16 August to 13 September 2023. All submissions received have been considered and amendments have been made to the local laws where required.

Council resolved on 8 November 2023 to adopt amended versions of 12 Local Laws and 4 Subordinate Local Laws. Council also resolved to make a new Local Laws being *Local Law No. 15 (Waste Management) 2023*. Officers will now commence a change management plan to ensure that Council is adequately prepared for the Local Laws to be implemented on 1 July 2024.



#### Footpath Dining

The annual footpath dining permit renewal process is a huge undertaking for the Local Laws Compliance and Regulatory Administration teams. The renewal and compliance process is important to minimise the risk to Council involved in footpath areas being utilised without the appropriate permit and insurance in place. As part of this process 150 renewal notices were issued to permit holders across the region with 75 of these permit holders receiving a reminder notice.

The Local Laws Compliance team then hand delivered 38 Compliance Notices from Babinda to Palm Cove explaining what was required to be compliant.

The team also followed up with phone calls where required to ensure the requirements were clearly explained. This process has been a success with 148 of the 150 (99%) permit holders now having gained compliance. Session Agenda - Ordinary Meeting - 22 November 2023 - #7305871
