SOLE SUPPLIERS AND SPECIALISED SUPPLIERS 2023/24 – UPDATE

RECOMMENDATION:

That Council:

- 1. Resolves in accordance with section 235(a) and 235(b) of the *Local Government Regulation 2012*, it is satisfied that the nominated suppliers listed in Attachment 1 are Sole or Specialised Suppliers and that they be added to the Sole Supplier Register for the remainder of the 2023/24 financial year.
- 2. Delegates authority to the Chief Executive Officer in accordance with the *Local Government Act 2009* to enter into contracts, negotiate, finalise and execute any and all matters associated with or in relation to Sole or Specialised Suppliers subject to Council's normal procurement policies and practices.

EXECUTIVE SUMMARY:

Section 235(a) and 235(b) of the *Local Government Regulation 2012* allows an exemption to inviting written quotes or tenders where Council resolves that there is only one sole or unique supplier or a specialised supplier, who is reasonably available to meet operational needs. Sole and Specialised Suppliers are used in instances where only one supplier is available due to specialised or unique services, or where services are confidential in nature that makes it disadvantageous or impractical to undertake a competitive procurement process.

In 2023, Council approved the appointment of 123 suppliers to the Sole Supplier Register and the removal of eight suppliers for the 2023/24 financial year. This report recommends an additional five suppliers be approved and provides justification for their inclusion to the Sole Supplier Register found in Attachment 1.

The current year to date expenditure on all Council Supplier's for the first half of the 2023/24 financial year (1 July 2023 to 31 December 2023) based on expenditure data is approximately \$100.6 Million. The current estimated year to date expenditure on existing Sole and Specialised suppliers from purchase orders is approximately \$6.3 Million, which represents approximately 6.3% of Council's total procurement activities.

BACKGROUND:

The Local Government Regulation 2012 (Regulation) requires written quotations or tenders be invited for procurement of works or the supply of goods or services that are greater than \$15,000 (medium sized contracts) or \$200,000 (large sized contracts) respectively. Council's Procurement Policy contains provisions or guidelines for obtaining quotes for less than \$15,000.

The Regulation acknowledges that there are instances when it is not always possible to meet these procurement guidelines in the market and therefore it provides a number of exceptions, including the following under sections 235(a) and 235(b):

235(a) – "The local government resolves it is satisfied that there is only one supplier who is reasonably available."

235(b) – "The local government resolves that, because of the specialised or confidential nature of the services that are sought, it would be impractical or disadvantageous for the local government to invite quotes or tenders".

This report is a continuation of a practice which commenced in 2012. There may still be occasions where it will be necessary to present an individual Council report during the year if an unforeseen need arises for a Sole or Specialised Supplier.

To be listed as a Sole or Specialised Supplier, Council officers must provide evidence that the supplier is the only supplier that can reasonably provide a particular good or service required. The emphasis is on the word "reasonably". For the purposes of this report, this means that if there is only one supplier in the rate-paying region of Cairns and they are considered to be providing a competitive service or offer unique products, then they can be deemed a sole supplier. The purchase of goods and services from a sole source to support the service and maintenance of existing assets from an original equipment manufacturer who has proprietary rights can also be deemed a sole supplier.

The commentary to section 235(a) and 235(b) of the *Local Government Regulation 2012* (last updated 12 July 2021) states that this section might be applied where Council is using a proprietary computer software program and wishes to upgrade that program to add functionality. There is generally only one possible supplier and the calling of tenders or quotes "would be a manifest waste of time and resources". This interpretation of the legislation has also been used to support and validate the inclusion of a number of sole supplier recommendations with regards to ICT software and maintenance of manufacturer's proprietary equipment.

Paragraph 235(b) gives Councils a broad power to determine that specialised or confidential services (not goods) may be provided pursuant to a private contract. Examples of this may be specialised engineering or legal advice in relation to controversial or confidential Council projects or in relation to matters where Council might have some legal liability.

COMMENT:

Council's Procurement Policy states that a Sole and Specialised Supplier report will be prepared every six months (biannually) and presented to Council. This report notes sole supplier expenditure for the first half of the 2023/24 financial year for those suppliers listed on the Sole Supplier Register.

In July 2023, Council approved the appointment of 119 suppliers to the Sole Supplier and Specialised Supplier Register for the 2023/24 financial year and the removal. In December 2023, Council approved an additional four supplier to support funding agreements.

This report recommends that an additional five suppliers be added for the remainder of the 2023/24 financial year. Current and newly added supplier details included on the Sole Supplier and Specialised Supplier Register can be found in Attachment 1. When nominating these suppliers, Council officers are requested to provide justification as to why this legislative exception should be considered for each supplier. A summary of this supporting justification is also listed in Attachment 1.

OPTIONS:

Option 1 (recommended):

It is recommended that Council:

- 1. Resolves in accordance with section 235(a) and 235(b) of the *Local Government Regulation 2012* that it is satisfied that the nominated suppliers listed in Attachment 1 are Sole and Specialised Suppliers and that they be added to the Sole Supplier Register for the remainder of the 2023/24 financial year.
- 2. Delegates authority to the Chief Executive Officer in accordance with the *Local Government Act 2009* to enter into contracts, negotiate, finalise and execute any and all matters associated with or in relation to Sole and Specialised Suppliers subject to Council's normal procurement policies and practices.

Option 2:

Council does not resolve to accept that the proposed suppliers are sole or specialised suppliers and request that Council officers proceed to call quotes and tenders for the supply of relevant products and services.

CONSIDERATIONS:

Risk Management:

Suppliers have been reviewed and those deemed not to meet the exemption requirements as per the definition of sole supplier in the Regulation have been excluded from this report.

Council Finance and the Local Economy:

The financial risk to Council is mitigated by Council officers having assessed these products and services as being suitable and the suppliers as being the only reasonable option from which Council can obtain these relevant products and services.

Corporate and Operational Plans:

Sole and Specialised Suppliers relates to the following strategies in Council's Corporate Plan 2021-2026 under the focus of Focus Five – Focused Council, Being a Leader in Government:

- Support an inclusive organisational culture that invests in continuous improvement, learning and leadership; and
- Ensure decision making is collaborative, transparent and accountable.

Statutory:

The Sole and Specialised supplier nomination has been conducted in accordance with legislative requirements under the *Local Government Act 2009* and the *Local Government Regulation 2012*.

Policy:

The Sole and Specialised Supplier nomination process has been undertaken in accordance with Procurement Policy amended and adopted on 7 December 2022.

CONSULTATION:

All relevant Council staff undertaking procurement are notified and consulted on a biannual basis and asked to nominate suppliers for the report. A Sole and Specialised Supplier Nomination Form must be completed and signed off by a relevant Executive Manager and Director. Procurement and Finance Branches have provided the expenditure information for this report.
