

### 9.4.3 Environmental performance code

#### 9.4.3.1 Application

- (1) This code applies to assessable development identified as requiring assessment against the Environmental performance code by the Tables of Assessment in Part 5.
- (2) When using this code, reference should be made to Part 5.

#### 9.4.3.2 Purpose

- (1) The purpose of the Environmental performance code is to ensure development is designed and operated to avoid or mitigate impacts on sensitive receiving environments.
- (2) The purpose of the code will be achieved through the following overall outcomes:
  - (a) development that has potential to cause an adverse impact on amenity of adjacent and surrounding land, or environmental harm is avoided through location, design and operation of the development;
  - (b) sensitive land uses are protected from amenity related impacts of lighting, odour, airborne particles and noise, through design and operation of the development;
  - (c) development ensure stormwater is discharged lawfully;
  - (d) development is located, designed, constructed and managed to avoid or minimise impacts arising from altered stormwater quality or flow;
  - (e) development contributes to the removal and ongoing management of weed species;
  - (f) development is located and designed to ensure that users and nearby sensitive land uses are not exposed to unacceptable levels of contaminants.
  - (g) development is designed and operated to ensure activities involving the use, storage and disposal of potentially hazardous materials and chemicals, dangerous goods, and flammable or combustible substances are located and managed to avoid or mitigate potential adverse impacts on surrounding uses, and minimise the health and safety risks to communities and individuals.

<b>Odour</b>	
<p><b>PO2</b> Potential odour causing activities associated with the development are avoided through design, location and operation of the activity.</p> <p>Note – Planning Scheme Policy – Environmental Management Plans provides guidance on preparing a report to demonstrate compliance with the purpose and outcomes of the Code.</p>	<p><b>AO2.1</b> The development does not involve activities that create odorous air emissions;</p> <p>or</p> <p><b>AO2.2</b> The use does not result in odour that causes environmental harm or nuisance with respect to surrounding land uses.</p>
<b>Noise</b>	
<p><b>PO3</b> Potential noise generated from the development is avoided through design, location and operation of the activity.</p> <p>Note – Planning Scheme Policy – Environmental Management Plans provides guidance on preparing a report to demonstrate compliance with the purpose and outcomes of the Code.</p>	<p><b>AO3.1</b> Development does not involve activities that would cause noise related environmental harm or nuisance;</p> <p>or</p> <p><b>AO3.2</b> Development ensures noise does not emanate from the site through the use of materials, structures and architectural features to not cause an adverse noise impact on adjacent uses.</p> <p>and</p> <p><b>AO3.3</b> The design and layout of development ensures car parking areas avoid noise impacting directly on adjacent sensitive land uses through one or more of the following:</p> <ul style="list-style-type: none"> <li>(a) car parking is located away from adjacent sensitive land uses;</li> <li>(b) car parking is enclosed within a building;</li> <li>(c) a noise ameliorating fence or structure is established adjacent to car parking areas where the fence or structure will not have a visual amenity impact on the adjoining premises;</li> <li>(d) incorporating a densely vegetated buffer adjacent to car parking areas.</li> </ul> <p>Note – The Environmental Protection (Noise) Policy 2008, Schedule 1 provides guidance on acoustic quality objectives to ensure environmental harm (including nuisance) is avoided.</p>

<p><b>PO4</b> Potential airborne particles and emissions generated from the development are avoided through design, location and operation of the activity.</p> <p>Note – Planning Scheme Policy – Environmental Management Plans provides guidance on preparing a report to demonstrate compliance with the purpose and outcomes of the Code.</p>	<p><b>AO4.1</b> Development does not involve activities that will result in airborne particles or emissions being generated;</p> <p>or</p> <p><b>AO4.2</b> The design, layout and operation of the development activity ensures that no airborne particles or emissions cause environmental harm or nuisance.</p> <p>Note – Examples of activities which generally cause airborne particles include spray painting, abrasive blasting, manufacturing activities and car wash facilities.</p> <p>Note – Examples of emissions include exhaust ventilation from basement or enclosed parking structures, air conditioning/refrigeration ventilation and exhaustion.</p> <p>Note – The Environmental Protection (Air) Policy 2008, Schedule 1 provides guidance on air quality objectives to ensure environmental harm (including nuisance) is avoided.</p>
<b>Waste and recyclable material storage</b>	
<p><b>PO5</b> Waste and recyclable material storage facilities are located and maintained to not cause adverse impacts on adjacent uses.</p> <p>Note – Planning Scheme Policy – Environmental Management Plans provides guidance on preparing a report to demonstrate compliance with the purpose and outcomes of the Code.</p>	<p><b>AO5.1</b> The use ensures that all putrescent waste is stored in a manner that prevents odour nuisance and is disposed of at regular intervals.</p> <p><b>AO5.2</b> Waste and recyclable material storage facilities are located, designed and maintained to not cause an adverse impact on users of the premises and adjacent uses through consideration of:</p> <ul style="list-style-type: none"> <li>(a) the location of the waste and recyclable material storage areas in relation to the noise and odour generated;</li> <li>(b) the number of receptacles provided in relation to the collection, maintenance and use of the receptacles;</li> <li>(c) the durability of the receptacles, sheltering and potential impacts of local climatic conditions;</li> <li>(d) the ability to mitigate spillage, seepage or leakage from receptacles into adjacent areas and sensitive receiving waters and environments.</li> </ul> <p>Note – The Environmental Protection (Waste Management) Policy 2008 provides guidance on the design of waste containers (receptacles) to ensure environmental harm (including nuisance) is avoided.</p>

<p><b>PO6</b> Sensitive land uses are not established in areas which will receive potentially incompatible impacts on amenity from surrounding, existing development activities and land uses.</p> <p>Note – Refer to the definition of Sensitive land use contained in Schedule 1.2.</p> <p>Note – Planning Scheme Policy – Environmental Management Plans provides guidance on preparing a report to demonstrate compliance with the purpose and outcomes of the Code.</p>	<p><b>AO6.1</b> Sensitive land uses are not established in areas where they will be adversely impacted by existing land uses, activities and potential development in an area;</p> <p>or</p> <p><b>AO6.2</b> Sensitive land uses may be established in areas of potential adverse amenity impacts where they mitigate all of the potential impacts through location, design, operation and maintenance.</p>
<b>Hours of Operation</b>	
<p><b>PO7</b> The operation of the development is limited to hours of a day that ensures the impacts on the amenity of nearby sensitive land uses are appropriately mitigated.</p> <p>Note – Regard will generally need to be given to the form of development and the location and appropriateness of the sensitive use impacted with respect to the outcomes also sought by the zone.</p>	<p><b>AO7.1</b> No acceptable outcomes are provided.</p>
<b>Lawful point of discharge</b>	
<p><b>PO8</b> Development activities are designed to ensure stormwater is directed to a lawful point of discharge.</p>	<p><b>AO8.1</b> Development activities are designed to ensure stormwater over roofed and hard stand areas is directed to a lawful point of discharge.</p>
	<p><b>AO8.2</b> Development ensures movement of stormwater over the site is not impeded or directed through potentially polluting activities.</p>
<b>Stormwater quality</b>	
<p><b>PO9</b> Development is planned, designed, constructed and operated to avoid or minimise adverse impacts on stormwater quality by:</p> <ul style="list-style-type: none"> <li>(a) achieving stormwater quality objectives;</li> <li>(b) protecting water environmental values;</li> <li>(c) maintaining waterway hydrology.</li> </ul> <p>Note – Planning Scheme Policy – Environmental Management Plans provides guidance on preparing a report, particularly a stormwater quality improvement plan, to demonstrate compliance with the purpose and outcomes of the Code.</p>	<p><b>AO9.1</b> A stormwater quality management plan is prepared, and provides for achievable stormwater quality treatment measures meeting design objectives listed in Table 9.4.3.3.b and Table 9.4.3.3.c, reflecting land use constraints, such as:</p> <ul style="list-style-type: none"> <li>(a) erosive, dispersive and/or saline soil types;</li> <li>(b) landscape features (including landform);</li> <li>(c) acid sulfate soil and management of nutrients of concern;</li> <li>(d) rainfall erosivity.</li> </ul>
	<p><b>AO9.2</b> An erosion and sediment control plan demonstrates that release of sediment-laden stormwater is avoided for the nominated design storm, and minimised when it is exceeded by addressing design objectives listed in Table 9.4.3.3.b for:</p>

<b>Hazardous materials, chemicals, dangerous goods, flammable or combustible substances</b>	
<p><b>PO11</b>                      The use, storage and disposal of potentially hazardous materials and chemicals, dangerous goods, and flammable or combustible substances are located and managed to avoid or mitigate potential adverse impacts on surrounding uses, and minimise the health and safety risks to communities and individuals.</p> <p>Note – Planning Scheme Policy – Environmental Management Plans provides guidance on preparing a report to demonstrate compliance with the purpose and outcomes of the Code.</p>	<p><b>AO11.1</b>                      No acceptable outcomes are provided.</p>

<b>Pest plants (for material change of use on vacant land over 1,500m<sup>2</sup>)</b>	
<p><b>PO12</b> Development activities and sites provide for the removal of all pest plants and implement ongoing measures to ensure that pest plants do not reinfest the site or nearby sites.</p> <p>Note – This does not remove or replace all land owner’s obligations or responsibilities under the Land Protection (Pest and Stock Route Management) Act 2002.</p>	<p><b>AO12.1</b> The land is free of declared pest plants before development establishes new buildings, structures and practices;</p> <p>or</p> <p><b>AO12.2</b> Pest plants detected on a development site are removed in accordance with a management plan prepared by an appropriately qualified person prior to construction of buildings and structures or earthworks.</p> <p>Note – A declaration from an appropriately qualified person validates the land being free from pest plants.</p> <p>Note - Declared pest plants includes locally declared and State declared pest plants.</p> <p>Note – Planning Scheme Policy – Environmental Management Plans provides guidance on preparing a report to demonstrate compliance with the purpose and outcomes of the Code.</p>
<b>Additional requirements for Port services</b>	
<b>Ship-source pollutants reception facilities</b>	
<p><b>PO13</b> Development provides facilities for the handling and disposal of ship-sourced pollutants.</p>	<p><b>AO13.1</b> Common user facilities for the handling and disposal of ship-sourced pollutants including oil, garbage and sewage are provided at a suitable location at the Port service.</p> <p><b>AO13.2</b> Facilities are designed and operated to ensure the risk of spillage from operations is minimised.</p> <p><b>AO13.3</b> Appropriate equipment to contain and remove spillages is stored in a convenient position near the facility and is available for immediate use.</p> <p><b>AO13.4</b> Boats visiting the marina are able to use the ship-sourced pollutants reception facilities.</p> <p>Note – Refer to the Australian and New Zealand Environment and Conservation Council (ANZECC), 1997, Best Practice Guidelines for Waste Reception Facilities at Ports, Marinas and Boat Harbours in Australia and New Zealand.</p> <p><b>AO13.5</b> The pollutant reception facility is connected to sewerage or other waste reception infrastructure.</p> <p>Note – Reception facilities require compliance assessment under the Plumbing and Drainage Act 2002.
