## **RECOMMENDATION:**

#### That Council:

1. Appoint [Councillor X] to fill the vacant Division 4 Councillor position.

## **EXECUTIVE SUMMARY:**

Council must appoint a new Councillor to fill the vacant position that has arisen following the retirement of former Mayor, Bob Manning and the appointment of Cr Terry James to the position of Mayor at Council's Ordinary Meeting of 22 November 2023

Under the Local Government Act (LGA) there is no requirement to hold an election to fill the vacant office of Councillor as the vacancy is now too close (within 12 months) to the next quadrennial local government election, set for March 2024.

Candidates' statements are included in the Agenda for Councillors' consideration.

Under Section 166B of the LGA, the vacant office must be filled by the local government appointing, by resolution a nominee who is qualified to be a Councillor.

### BACKGROUND:

Commencing on 22 November 2023, the Chief Executive Officer invited nominations from anyone who was qualified (in accordance with Section 152 of the LGA) to be a Councillor. Former candidates were individually notified, where the Electoral Commission of Queensland had the authorisation of the candidate to publicly release their contact details.

The notices seeking nominations were published in multiple media platforms, including Council's website, via media release to local media outlets and social media platforms.

Council received eight valid nominations and no invalid nominations by the submission closing date. The submissions received from the eight eligible candidates are attached to this report.

The Electoral Commission confirmed the enrolment of these candidates on the electoral roll.

## **COMMENT:**

Council will determine the candidate to be appointed as the new Councillor by way of the following process:

- The Mayor will chair the meeting.
- The report before the meeting will identify the names of all nominees qualified to be a Councillor, including their statement of selection.
- The Chair will move to suspend standing orders to allow more than one motion on the table.
- The Chair will call for a mover for a proposed nominee from the list contained herein to be appointed to the position of Division 4 Councillor.
- If there is a seconder, the nomination will lie on the table.
- Repeat until there are no more valid nominations.
- The Chair will then put to a vote the first nomination in the ordinary (and open)
  manner, as prescribed by section 254 of the Local Government Regulation 2012
  (the Regulation) and Council's Standing Orders. If a majority of Councillors vote
  to appoint the first nominee as Division 4 Councillor, that is the end of the
  Councillor appointment process.
- If the first nominee does not secure the majority support of Councillors, the motion to appoint the first nominee fails and the Chair then calls for a vote for the next nomination.
- The process will, if necessary, repeat itself again and again until a nominee receives a majority vote of Councillors.
- Once a nominee has the majority vote the chair will ask the remain nominees if they want to continue to have the votes called.
- Each Councillor has only one vote.

Following their appointment by Council the Mayor will swear in the new Councillor.

Council is following the requirements under the LGA to fill the vacant Division 4 Councillor position for the remainder of the term.

Under the LGA there is no requirement to hold an election to fill the vacant office of Councillor as the vacancy is now too close (within 12 months) to the next quadrennial local government election, set for 16 March 2024.

## **OPTIONS:**

Option 1:

**Appointment of Councillor** 

That Council:

1. Appoint [Councillor X] to fill the vacant Division 4 Councillor position.

## **CONSIDERATIONS:**

#### Introduction:

As a way of introduction, my name is Yohan Batzke but my community name Yodie, name given to me by my father. I am 58 years of age, married to my husband Hans of 34 years, and together, we have raised four wonderful children who have in turn blessed us with four grandchildren.

I have called Cairns home since 1971, when my parents late George and May Dewis made the decision to sell our family business on Thursday Island to relocate our family of 7 to Cairns in pursuit of better healthcare, education, and employment opportunities. My family ties and connections also extend to Babinda and Innisfail where my father's family still resides to this day. My primary school years were spent at Cairns West Primary School, Edge Hill Primary School, and Trinity Bay High School. Although my husband and I were absent from Cairns from 1995 to 2009, due to moving to Canberra to work in the Australian Public Service, our connection to Cairns has never ceased. During the past 52 years, I have witnessed many changes occur in the Cairns Regional Council footprint and surrounding regions socially, environmentally, economically, and politically.

#### Community and Business Experience:

I am also a former small business owner from 1996 to 2013 with core business services in: cultural awareness; trainer; event management conferencing and facilitation services; policy and procedural development; government ministerial services (in areas of compliance); community development and planning; preemployment services for long term unemployed; marketing; land tenure and native title; cultural heritage; strategic and operational planning; corporate governance training for not-for-profit community-based organisations and political advocacy.

When we began our business in Canberra in 1996 our main clientele at the time were Commonwealth Government Agencies and Statutory Bodies located in Canberra. This then extended nationally to private sector such as the aviation industry and State Government Departments.

From 1999-2002 our business activities were put on hold due to my successful election and appointment as the Aboriginal and Torres Strait Islander Commission (ATSIC) Queanbeyan Regional Council Chairperson, NS. Our total number of elected Councillors for the region was 12, with the statutory responsibility of overseeing the annual distribution of our Council's annual budget of approximately \$36 million. The ATSIC Regional Council footprint was inclusive of ACT and the southeast region of NSW from Nowra to Eden, also inclusive of a second Territory Jervis Bay. During that time, I had also served on several Government appointment Ministerial portfolios representing ATSIC on the NSW Aboriginal Housing Board, NSW Health Forum, Southeast Regional Sea Forum and Youth Justice.

I have been a strong community advocate in all communities we have lived in. Reflecting on my historical connection with Cairns, spanning over 52 years, I have witnessed many changes occur in the Cairns Regional Council footprint and surrounding regions socially, environmentally, economically, and politically. Although I no longer operate a business, my business ethics and life skill experiences continue to play an integral part in my role as a community advocate.

#### Commitment to Diversity, Collaboration and Communication:

During the past two Cairns Regional Council terms, I have also been an active member of the Cairns Regional Councils First Peoples Advisory Committee, Reconciliation Action Plan Advisory Group and member of the Cairns Multi-Cultural Reference Group on the proposed design of a Multi-cultural Centre here in Cairns. I have also made it my business to contact various Council Staff members to seek further clarification on community development issues that have been brought to my attention or felt compelled to advocate for.

Understanding the important role of the Elected arm of Council, as a community advocate, I have made it my business to raise in the broader context infrastructure needs, safety in parks, prevention of youth suicide, community centres; housing; economic and enterprise development needs of the community. However, some of the more specific issues I have raised with Councillors for the past 12 years are as follows:

- Division 1 Clr Moller broken bottles at the Aloomba Creek causeway.
- Division 3 Former Clr Rob Pyne on the new overpass bridge at White Rock where I raised concerns of safety issues regarding debris being thrown at oncoming traffic from the bridge overpass.
- Division 4 CIr Terry James raising issue re-opening McFarlane Drive as an alternate route for residents and the outstanding rates not being paid by a not-for-profit community organisation.
- Division 5 Former Clr Richie Bate safety issues for tourists arriving early hours of the morning by Greyhound and no taxi or public phones accessible when arriving at Fogarty Park and then having to walk several blocks to accommodation; issues around homeless residing in the city centres and parks; the need for a basketball court to be located on the esplanade; condition of playground equipment at Shang Park, Mooroobool (damaged after cyclone); requesting an audit to be done on Council parks absent of lighting and lobby for parks to have a solar power generated lights to be put in parks (purpose to prevent parks from being used for illegal activities or places used by individuals as a potential place to commit suicide), acts of violence against women and children, and old sewage systems causing damage to homes from torrential rain and flooding.
- Division 6 Former CIr Linda Cooper on extensive debris causing major blockage of a causeway bridge near Brady Close; CIr Kristy Vallely on safety concerns and issues of illicit activities happening under the bridge at located near Coolwaters.
- Division 7 CIr Max O'Halloran on itinerates camping along Saltwater Creek and cooking local wildlife (small campfires made along bike paths) and itinerates sleeping in Centenary Lakes parks and gardens.
- Former Mayor Bob Manning seeking CRC donations and support for the friends of the 8 Children who passed away on Murray Street.

#### Commitment to Constituents & Council::

In addition to contacting the elected arm of Council, if there was a need to seek further information on community projects, Council Staff of the Community Development, Community Sport & Cultural Department (now referred to as the Lifestyle & Community) have always made time to meet to discuss the Council's directions in meeting our communities' aspirations.

Not to be <u>polarised</u> by issues affecting not only a certain sector of our community but collectively as a Region, I am confident my life skills and ability to communicate with a diverse group a people, business, ministerial and advocacy, but more importantly my commitment to our community, can only be a positive contribution in advancing the needs of constituents in Division 4 for the remainder of this Councils term.

In conclusion, my reasons for submitting this nomination form are based on my unwavering, passionate support of the Cairns community as an active community advocate and understanding the important role Local Government Association's play, in meeting the hopes and aspirations of constituents. If I am successful in being appointed Councillor of Division 4, my commitment in advocating for and on behalf of all community members, business owners, schools, and community organisations will continue.





I have had to work extremely hard, (harder than most) to overcome adversity. I have faced many challenges, disadvantages and barriers. I was raised by a single mother who struggled and (sometimes) an alcoholic father. On one occasion, He forgot he had children and the two of us slept outside beneath a door mat. I was 4 and my brother 2. I was later subjected to sexual abuse by older cousins. The challenges I faced were not limited to childhood, extending to teenage years and my early 20s where I spent six months in prison. When I arrived in Cairns, I tried taking my own life on the Esplanade. I experienced homelessness and spent time in Quigley Street Crisis Accommodation and OzCare (Anglicare) Homeless Men's Hostel (adjacent to Council on Draper Street). I have changed my life here in Caims and this is just one of the many reasons why, I am so passionate about giving back to our community and making it a better place. You are all aware of my strong community commitment, recognised by this Council in 2021 and 2023 for volunteering, each of you have witnessed personally. (Amy Eden and Cr Vallelly at the Mayors Christmas Appeal and Cr Olds and Coghlan at Crankworx and Ironman etc..) I was recently conferred with my second degree, a bachelor of laws from CQU where I am currently Law Society President. Incredible, having only completed 4-5 years of schooling, with no year 10 or 12 certificate. I have received and continue to receive national

attention for my positive community contributions and advocacy regarding some of the most significant issues facing Queenslanders such as homelessness and youth crime. News.com.au published a complete profile from early childhood through to my present run for Council and Mamamia discussed the important work I do with men, to reduce domestic and family violence across Australia. Every Councillor present, has seen me sitting in this Chamber the last two years, committed to learning Council processes and staying up to date on issues affecting Cairns residents. Not one other Council candidate has shown such dedication and commitment. Not only have I been present, during most Council meetings but my influence in them has been felt in this Chamber many times. I was pivotal in organising the deputation to Council by my friend, formerly incarcerated Human Rights lawyer Deb Kilroy, that moved Councillor Vallelly so deeply, the meeting was adjourned. My nomination is backed by the community. More than 250+ residents signed a pledge supporting my nomination over the weekend. It is a 'no brainer' that any nominee seek the support of the community. Finally if appointed, I'll be donating to charities based in Cairns, I don't need the paycheck. Councillors have an opportunity here to appoint someone that is both capable and committed, Councillors can make a decision that is just, right and fair but also one that feels good and inspires others.
