Notes for Applicants

1. The Council Pensioner Remission will only apply if all owners meet the eligibility requirements.
2. The applicant/s must be the registered owner/s or life tenant (either solely or jointly) of the property within the boundaries of Cairns Regional Council which is his/her principal place of residence. The State Government Subsidy/Council Pensioner Remission is not applicable on vacant or leasehold land, or rental properties.
3. The applicant/s must hold a valid **Queensland 'Pensioner Concession Card'** issued by Centrelink, or the Department of Veterans' Affairs, or a **Queensland 'Repatriation Health Card – For All Conditions' (Gold Card)** issued by the Department of Veterans' Affairs. 4. The State Government Subsidy/Council Pensioner Remission will commence from the date the application is submitted to Council and will not be applied retrospectively.
5. Any rate notice issued prior to the date the application is received, must be paid by the due date for payment (as indicated on such notice) to prevent interest charges being incurred.
