EXECUTIVE SUMMARY:

Section 256 of the *Local Government Regulation 2012* states that the matters that Council must consider at the post election meeting includes the day and time for holding other meetings.

According to section 257 of the *Local Government Regulation 2012* Council's must meet at least once in each month and that all meetings are to be held at one of the local government's public offices or for a particular meeting – at another place fixed by the local government, by resolution, for the meeting.

It is proposed that Council schedule the first Ordinary Meeting for Wednesday 22 April 2020 and every second and fourth Wednesday of each month thereafter. These meetings would be held in Council Chambers at Spence Street commencing at 9am unless otherwise determined.
