### FNQROC Development Manual v7 - Additional Clause D9.04 General

Approved local Landscape Architects and Landscape Designers maybe eligible to be listed on the Approved Landscape Architect and Designer's Register available on the Council's website. Inclusion to this list will be subject to a strict selection process and annual review. To be included on the list, the applicant must be regularly producing plans of a high standard that are generally acceptable to Council, including content and consistency of presentation.

## Register of Landscape Designers and Landscape Architects

### Qualified Landscape Architects

Are any persons or company within Australia who has a current membership with the Australian Institute of Landscape Architects (AILA).

### Landscape Designer

Designers on Council's "Register" have demonstrated to the Council that they fulfill the following criteria:

- They have demonstrated a sound knowledge of the Council's *FNQROC Development Manual*;
- They are familiar with the Council's City In A Garden Strategy, the CBD Streetscape Master Plan and the Marlin Coast Landscape Master Plan;
- Long-term experience in the landscaping industry, especially in the tropics;
- They have submitted several landscaping plans of acceptable quality to the Council as part of applications for approval of 'Operational Works' or 'Building Approvals' and
- They check their plans against the particular conditions of the Development Approvals and the Landscaping Code and Performance Criteria for that type of development in CairnsPlan.

### Admission to the Council's Register

Any person who wishes to be included on the Council's Register should submit a written application, including their Curriculum Vitae for consideration. The application should be addressed to:

### Application and fees for Endorsement of Landscaping Plans

Landscaping plans will be processed with minimal delay by Council if prepared and certified in accordance with Councils requirements by practitioners listed on Council's Register.

The Council's application fees for assessment of landscaping plans are always in accordance with the Council's current Fee Schedule. One fee charge is payable for each submission made for a single property, that is one stage of a subdivision or one private development as part of the building application.
