RECOMMENDATION:**That Council adopts the Bluewater Canal Special Charge Annual Implementation Plan 2022/23.****EXECUTIVE SUMMARY:**

This report provides a summary of the actions required in regard to adopting the Bluewater Canal Special Charge Annual Implementation Plan 2022/23.

Council is required to preserve, maintain and keep clean any canal within its area including access channels, in accordance with section 121 of the *Coastal Protection and Management Act 1995*.

Council must have an overall plan for each special rate or charge. An overall plan is a document that sets out the estimated costs, timeframe and nature of the activity to be provided. It also identifies the rateable land to which the special charges are to be applied. On 30 June 2021 Council adopted the Bluewater Canal Special Charge Overall Plan 2021/22 - 2030/31.

Each financial year, Council is required to adopt an annual implementation plan for the special rate or charge. An annual implementation plan is a document that sets out the actions and processes that are to be carried out in the current financial year for the activity to which the special rates or charges apply.

The Bluewater Canal Special Charge Annual Implementation Plan 2022/23 is to undertake the following actions as required:

- dredging of the Bluewater Canal, Half Moon Creek and Offshore Channel, including spoil disposal;
- maintenance of channel markers and lights;
- hydrographic surveys; and
- administration and project management of the dredging program

It is recommended that Council resolves to adopt the Bluewater Canal Special Charge Annual Implementation Plan 2022/23.

BACKGROUND:

Council is required to adopt an annual implementation plan for each special charge each financial year. The annual implementation plan describes how the overall plan for the special rate or charge will be executed in the financial year.

OPTIONS:

Option 1 (recommended):

Council resolves to adopt the Bluewater Canal Special Charge Annual Implementation Plan 2022/23

Option 2:

That Council suggest changes be made to the Bluewater Canal Special Charge Annual Implementation Plan 2022/23

CONSIDERATIONS:

Statutory:

Adoption of the Bluewater Canal Special Charge Annual Implementation Plan is in accordance with Sections 92 and 94 of the *Local Government Act 2009* and Section 94 of the *Local Government Regulation 2012*

CONSULTATION:

Preston Law were consulted regarding the documentation and processes required for adopting the Special Charge for the Bluewater Canal Dredge.

7. Overall Plan

Cairns Regional Council adopted an Overall Plan for levying a special charge upon rateable land for the dredging of Bluewater Canal, Half Moon Creek and Offshore Channel on 30 June 2021.

The Overall Plan specifies that:

- a. The rateable land to which the special charge applies is specified in Attachment 1;
- b. The activity for which the Overall Plan is made is the dredging and maintenance of Bluewater Canal, Half Moon Creek and Offshore Channel specified in Attachment 2 and providing for as the major elements:
 - dredging of the Bluewater Canal, Half Moon Creek and Offshore Channel, including spoil disposal;
 - maintenance of channel markers and lights;
 - hydrographic surveys; and
 - management and administration of the dredging and maintenance program, including obtaining required permits and contractor evaluation and selection;
- c. The time for implementing the Overall Plan is ten (10) years, beginning on 1 July 2021 and ending on 30 June 2031; and
- d. The estimated cost of implementing the Overall Plan is \$8.2M across the ten (10) year period after allowing for contributions of \$0.3M from the Department of Transport and Main Roads.

8. Annual Implementation Plan 2022/23

2.1. Action

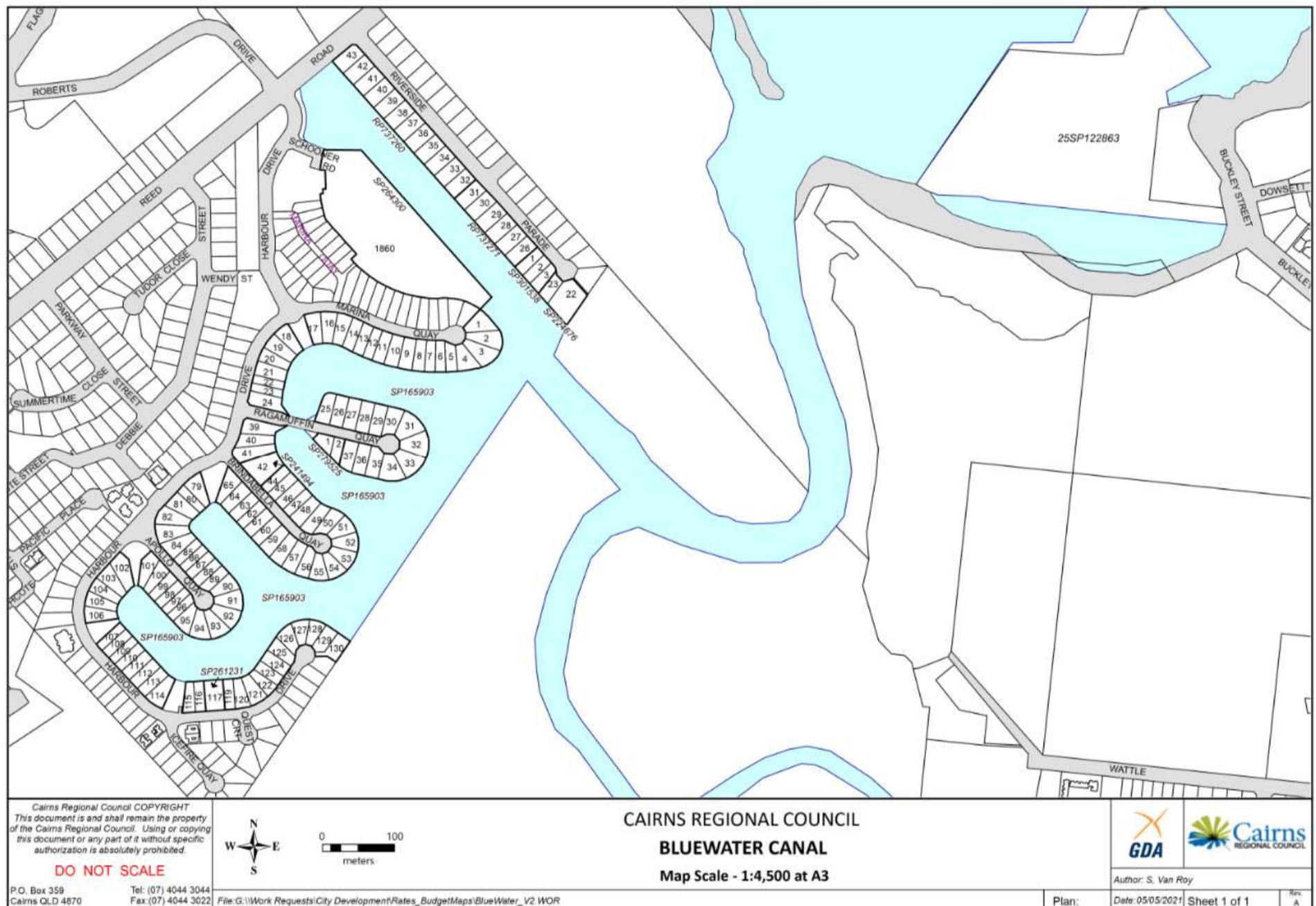
The Annual Implementation Plan for the 2022/23 financial year is to undertake the following actions and processes as required:

- a. the dredging of Zone A, Zone B and Zone C as shown in Attachment 2, including spoil disposal;
- b. maintenance of channel markers and lights;
- c. obtaining hydrographic surveys; and
- d. management and administration of the dredging and maintenance program.

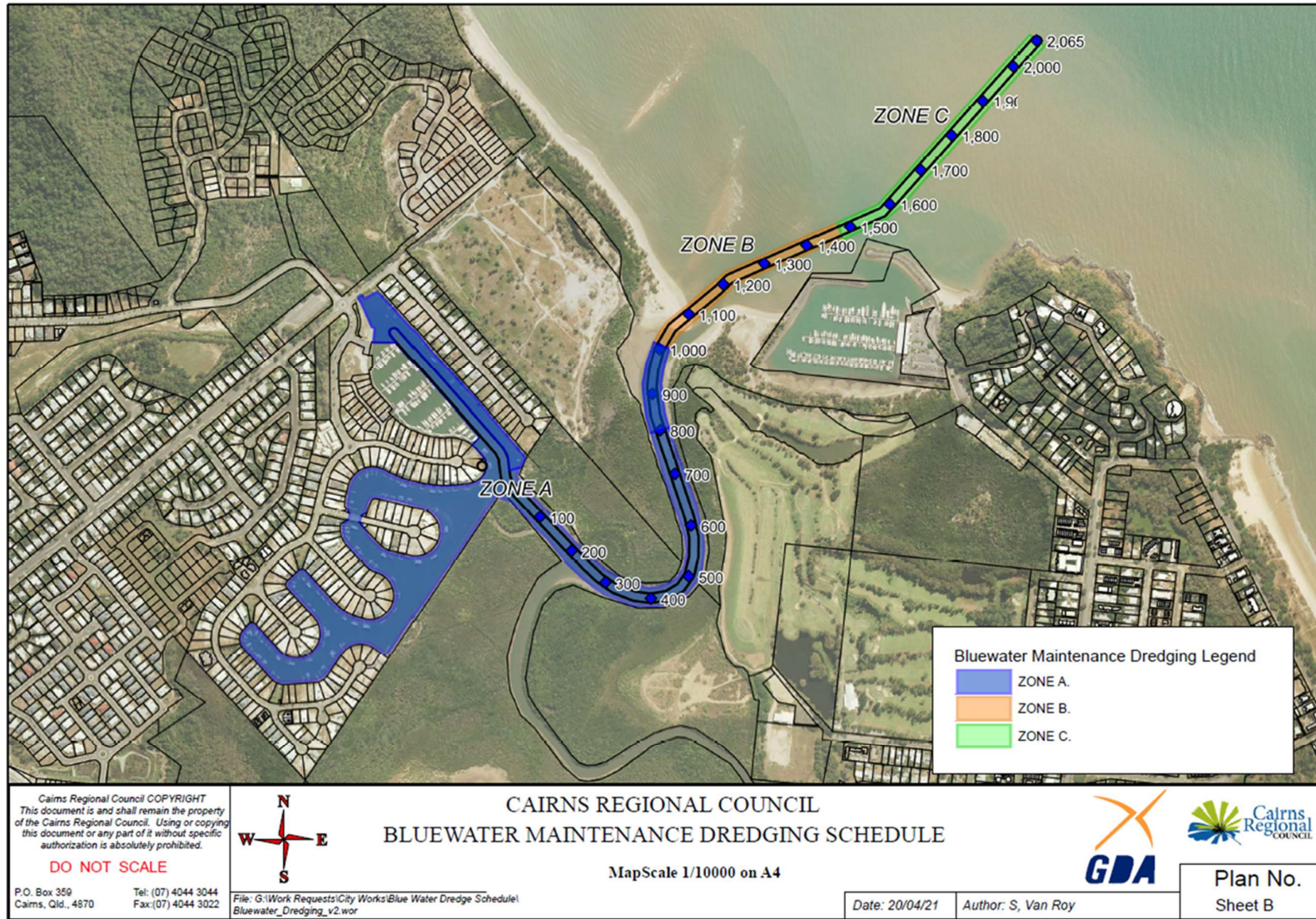
