EXECUTIVE SUMMARY:

Cairns Choral Society has played a key part in the Cairns region's programming calendar and has actively presented shows at Cairns Performing Arts Centre (CPAC) and the former Civic Theatre for over 40 years.

The Cairns Choral Society is a key community group that contributes significantly to the cultural fabric of the city and is an organisation that Council officers would like to see continue their pivotal work in the region.

Cairns Regional Council entered an initial one-year Resource and Performance Agreement (R&P) with the Choral Society, expiring 31 December 2023, to provide up to \$35,000 in-kind (not cash) to support their annual musical, gala event and senior eisteddfod ticketed performances at CPAC for venue hire, personnel and associated resources.

It was noted in a previous report to Council on 16 November 2022 that an extension of the R&P may be requested to provide similar support for the next two financial years. The organisation has now finished their performances for the 2023 year and successfully submitted their outcome report and is requesting further support.

The recommendation of this report is to enter into a further two-year R&P with the Cairns Choral Society and provide up to \$50,000 in-kind (not cash) support for their annual musical and gala events. Council officers recommend that the new R&P be established before the initial agreement expiry date in order to secure support prior to their January 2024 musical *Les Misérables*.

The proposed support from Council totals \$50,000 in-kind over a two-year period from 1 January 2024 until 31 December 2025 and will encompass budgets from 2023/24 and 2024/25

BACKGROUND:

The Cairns Choral Society celebrated its 100-year anniversary in 2023 and has been presenting high profile events including popular musicals for over 40 years to the Cairns region. They are a not-for-profit community group that operates out of their facility in Edge Hill and run a range of events both at their hall and at CPAC. The Society's productions include an annual gala performance, an annual musical production and a senior eisteddfod.

The Choral Society Gala is a variety show held annually in October and features a range of local dance, music and theatre performers. The senior eisteddfod is a biennial event between Cairns and Townsville and is held over four days, focusing on a singing competition for all age groups from 17 to 85. The annual musical held in January, encompasses a three-week season presenting a high quality production of a popular musical. It is one of the few local opportunities for the community to participate in a large-scale musical production.

COMMENT:

Cairns is fortunate to have a Choral Society who operate under a not-for-profit status and manage high-profile community events. Due to the regional nature of our city, we do not yet have the financial capabilities to fund a commercial musical delivery in Cairns, making the Choral Society's musical production the only one of its kind in Cairns.

Their productions attract people of all ages who want to work in a team-oriented environment where they can gain experience in areas such as performance, marketing, production, administration, budgeting, front of house, and set design/building. The organisation has been supporting community members for over 40 years and has become an important part of the Cairns arts and cultural community by providing a key platform for people in Cairns to sing, dance and act.

The Choral Society has produced a program report evaluating their productions held this year, as well as financial statements (see Attachment 1).

OPTIONS:

Option 1: (Recommended)

That Council:

- 1. Approves establishing a two-year Resource and Performance Agreement with Cairns Choral Society; and
- 2. Delegates authority to the Chief Executive Officer in accordance with the *Local Government Act 2009* to finalise any and all matters relating to the above agreement.

Option 2:

That Council requests further information.

Option 3:

That Council does not support the establishment of a Resource and Performance Agreement with Cairns Choral Society.

CONSIDERATIONS:

Risk Management:

The ticket price for events provides reasonable income for the community organisation but may limit accessibility to the wider community. This is considered a minor risk as the ticket price for all events is considered to be modest, particularly the musical which, for a high-profile production is comparable to those presented in southern states. This is evidenced by ticket sales, with the Choral Society usually selling out a three-week season every January.

Should the Choral Society not receive support from Council there is the chance the Society will need to limit their annual productions at CPAC. All events, and specifically the musical, utilise the full facility (including fly lines) making good use of the significant financial investment from Council to build the venue. The cost of putting on these productions is growing and with support from Council the Choral Society will be able to continue their pivotal work in providing culturally enriching content to the Cairns community.

Council Finance and the Local Economy:

It is proposed that this R&P requesting up to \$50,000 is allocated via the following budget allocations:

The Choral Society has noted that they would like to extend the request for support in subsequent years and similar allocations above existing Arts and Cultural In-kind grant streams will be addressed in the new financial year budget considerations.

Community and Cultural Heritage:

The proposed new funding agreement to provide in-kind support to Cairns Choral Society is aligned to the cultural, heritage and community development aspirations of Council's Strategy for Culture and the Arts 2022 as outlined below:

Priority 3.1 Programming, Promotion and Audience Development:

<u>Strategy 3.1.1</u>: Align Council's flagship venues to produce an annual performing and visual arts program that provides entertainment and cultural experiences as good as any Australian capital city and promote Cairns as an international creative powerhouse.

<u>Comment:</u> Cairns Choral Society provide the only annual musical season performing a high-class production over several weeks to the Cairns community. This provides the Cairns Community with a signature musical season every January which contributes to a balanced cultural event portfolio, provides culturally enriching content of a high-profile nature, and gives the Cairns community access to something they would otherwise have to travel outside the region to see.

<u>Strategy 3.3.1:</u> Raise our global profile as a sophisticated and vibrant centre of creative and cultural excellence through partnerships, collaboration, and critical mass.

<u>Comment:</u> Choral Society produce high profile productions that stage some of the region's most artistic people and through these partnerships Council will be able to raise the profile and calibre of content at our cultural venues.

Corporate and Operational Plans:

The proposed new funding agreement is aligned to Council's corporate and strategic goals, in particular:

- Promote Cairns as the arts and cultural capital of Northern Australia.
- Support diverse sport, cultural and community groups that contribute to wellbeing.
- Provide spaces and programs for the wellbeing of the community.

The funding also aligns with Operational Plan strategy actions:

Deliver vibrant cultural events and activities for locals and visitors.

CONSULTATION:

Council officers have consulted with Cairns Choral Society and will continue to liaise with the organisation's Artistic Lead and Creative Producer in the ongoing roll out of the agreement.

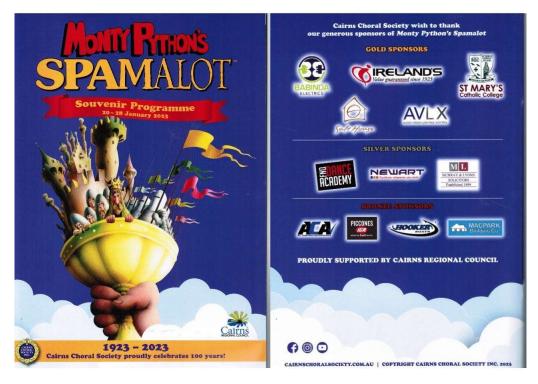

<u>2024 – 2026 Shows Requiring Future Funding Assistance</u>

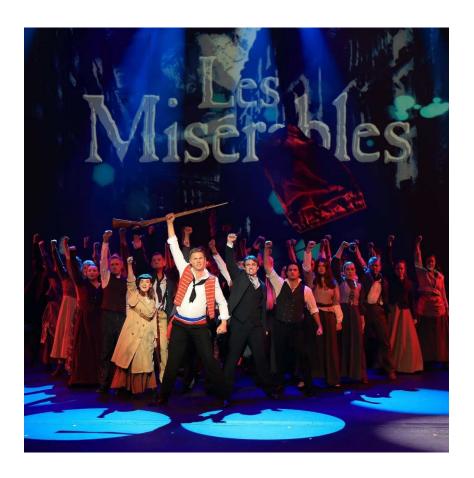
As the Cairns Choral Society celebrates its 100th anniversary we are thrilled to announce our upcoming production of *Les Misérables* in 2024. This landmark event is not only a testament to our history of producing popular, modern musicals but also a significant milestone in our commitment to bringing exceptional musical experiences to the Cairns community. The Cairns Choral Society were the first amateur production group in the world to produce the show back in 1993 and we will be the last amateurgroup in Australia to perform it before it returns to the professional arena later in 2025.

However, staging a production of this scale requires substantial financial resources for set manufacture, costume design, upfront marketing, and royalty expenses. As we embark on this ambitious journey, the Choral Society will be dipping into our overdraft account to help fund our show.

To help us put on future productions the Cairns Choral Society needs the assistance of the Cairns Regional Council for our 2024 -2026 period to help us keep afloat. Our general running cost are an average of \$75,000 per annum to pay for our insurances, electricity and the general maintenance on our building in Greenslopes St. The in-kind assistance for the CPAC costs for our events in the theatre, allows the society to create high quality productions.

The North Queensland Eisteddfod will not be held in Cairns again until 2026 but our Gala Spectacular willbe held as always at CPAC in October 2024, 2025, 2026 and beyond. We will also be having a musical inour usual time slot of January 2025 and January 2026.

To assist in your decision, below is the predicted budget to produce Les Misérables in 2024. Also included is our current balance sheet and our profit and loss reports for January 2023 to October 2023.
