COMMUNITY PARTNERSHIPS GRANT - CAIRNS AGRICULTURAL PASTORAL AND MINING ASSOCIATION

RECOMMENDATION:

That Council:

- Supports the application received from the Cairns Agricultural Pastoral and Mining Association for the 2024 Cairns Show and enters into a one-year Resource and Performance Agreement to the value of \$70,000 (ex GST).
- 2. Delegates authority to the Chief Executive Officer in accordance with the Local Government Act 2009 to finalise any and all matters relating to the above agreement.

EXECUTIVE SUMMARY:

The Cairns Agricultural Pastoral and Mining Association has submitted a Community Partnerships Grant application to Council to assist with the delivery of The Cairns Show held at the Cairns Showgrounds from 17 to 19 July 2024.

The formal request to Council is for a total of \$70,000 (ex GST) for the delivery of the 2024 event. Given the significance of this annual event, and the economic impact on the economy of Cairns, officers propose that Council enter into a one-year Resource and Performance Agreement providing a total of \$70,000 (ex GST), consisting of up to \$25,000 in-kind (ex GST) and \$45,000 cash (ex GST).

BACKGROUND:

The intent of the Community Partnerships Grant is to assist community groups and organisations with the delivery of events, activities and programs that enhance the lives of local communities, celebrate important community occasions, and provide opportunities to develop social cohesion and connection in the Cairns region.

The Cairns Agricultural Pastoral and Mining Association has been considered for funding because the event aligns with the objectives of the Community Partnerships Grant stream, specifically as the event:

- Drives community and social outcomes to enhance the overall quality of life in local communities.
- Contributes to the region's balanced portfolio of community, arts, cultural and sporting events.
- Celebrates the rich traditions of communities and the importance of these to the Cairns region.
- Drives future growth and sustainability of local events, activities and programs.

COMMENT:

The annual Cairns Show, which began in 1891, is a three-day agricultural, pastoral, horticultural, industrial, art, craft, cultural, historical, mining and community event that includes a variety of competitions, demonstrations and exhibits of farming and commercial goods, arts and crafts, educational information, entertainment, sideshows and amusement rides.

The Cairns Show is the largest regional show in Australia and will take place from 17 to 19 July 2024, making it a key event in the region's social calendar. Volunteers, performers, exhibitors, community groups, emergency services, schools and families all participate in the accessible and inclusive event.

This year, the Cairns Show was successfully delivered with a total of 65,517 people attending the event over the three days. The Cairns Show provided local businesses with the opportunity to advertise and showcase their products to customers in Cairns and the surrounding areas, whilst also offering additional employment opportunities in the region.

The 2024 Cairns Show is expected to attract approximately 70,000 people of which 13,759 are projected to be intrastate visitors. The potential direct and indirect economic impact of the 2024 Cairns Show is estimated to be \$1,218,838 to the Cairns region.

Since 2016, Council has resolved to the support Cairns Agricultural Pastoral and Mining Association for the delivery of The Cairns Show.

Cairns Agricultural Pastoral and Mining Association is requesting \$70,000 (ex GST) towards the delivery of the 2024 Cairns Show.

Officers are supportive of this request and recommend providing support up to \$70,000 (ex GST) consisting of \$45,000 (ex GST) cash and the provision of up to \$25,000 (ex GST) in-kind assistance.

OPTIONS:

Option 1: (Recommended)

That Council:

- 1. Supports the application received from the Cairns Agricultural Pastoral and Mining Association for the 2024 Cairns Show and enters into a one-year Resource and Performance Agreement to the value of \$70,000 (ex GST).
- 2. Delegates authority to the Chief Executive Officer in accordance with the *Local Government Act 2009* to finalise any and all matters relating to the above agreement.

Option 2:

That Council does not support this recommendation and adopts an alternative funding allocation.

CONSIDERATIONS:

Risk Management:

Cairns Agricultural Pastoral and Mining Association Committee Member Nathan Lee Long is running as a candidate for Cairns Division 5 in the 2024 Local Government elections. Officers confirm that this has had no bearing on the recommendations contained within this report.

Visitation

As the tourism economy recovers post-COVID, aviation routes are still disrupted and not at full capacity for domestic or international travel into Cairns. This capacity, along with increased airline and hotel pricing and consumer confidence may have an impact on visitation numbers, though it is noted that a conservative approach has been taken when assessing potential event visitation and economic benefits.

Council Finance and the Local Economy:

The recommended cash funding can be accommodated within Council's Community Partnership Grant funding allocation for 2023/2024. The in-kind support will be taken from the proposed 2024/2025 Community Partnerships Grant funding allocation.

Budget considerations – 2023/2024

- The Community Partnerships Grant has an allocation of \$684,575 (ex GST) for the 2023/2024 financial year.
- \$464,681 (ex GST) of funds have already been allocated.
- Recommended funding in this report amounts to \$70,000 (ex GST).

• The remaining balance available for distribution within the 2023/2024 budget is \$174,894 (ex GST).
