This form is to be used for vehicles requiring access to the restricted areas of **Sheridan Street** (vehicles with a gross vehicle mass (GVM) greater than **8 tonne** to traverse Sheridan Street between Florence and Spence Streets during the restricted hours of 6am to 6pm) and **The Esplanade** (vehicles with a gross vehicle mass (GVM) greater than **6 tonne** to traverse The Esplanade between Florence and Spence Streets during the restricted hours of 10am to 4pm and 7pm to 6am).

## Application for a Restricted Vehicle Access Permit

### CONDITIONS OF ISSUE AND USE FOR HEAVY VEHICLE ACCESS PERMITS

1. You must apply for a Restricted Vehicle Access Permit (permit) in writing on a standard application form.
2. Any permit which is copied, reproduced in any fashion, or sold will be cancelled and may not be replaced.
3. Any permit which is obtained as a result of providing false or misleading information will be cancelled and the permit holder will be ineligible to obtain a permit for a period of 12 months. Any vehicle(s) for which a permit is issued will also be ineligible for a permit for a period of 12 months.
4. The permit will expire on the date shown on the permit. The permit is issued for a period of one year or part thereof.
5. The Cairns Regional Council will endeavour to process all permit applications within 10 working days of receipt.
6. The permit will show the registration number of the vehicle for which it is issued. It is not transferable.
7. The Cairns Regional Council reserves the right to withdraw this permit at any time.
8. The Cairns Regional Council reserves the right to change the Conditions of Issue and Use of this permit at any time.

### SUBMISSION OF APPLICATION

Please allow up to 10 working days to process this application. By submitting this application, the Applicant is consenting to agree to the terms and conditions identified above. The applicant can appeal these conditions in writing. The appeal is to be attached to the application with the conditions to be appealed, struck out on the application.
